### RV/CAMPER PARKING RESERVATION FOR 2009 USC FOOTBALL GAMES

**Overnight parking is limited to fully self contained vehicles. You must have sewer, water tanks and electrical capabilities. There is no sleeping in vans, tents, cars or cargo trailers.**

RV/Camper lot opens Friday at 2:00pm and closes Sunday at 2:00pm. There is a 10% surcharge for a cancellation and **there are no refunds for season permits after August 15<sup>th</sup>**. Refunds will be made as soon as your permit(s) are returned.

## Overnight Park Rules and Regulations

NO REFUNDS ARE ISSUED WITHOUT A 7 DAY CANCELLATION NOTICE. THERE IS A 10% SURCHARGE FOR ALL CANCELLATIONS, CHECK OR CHARGE. REFUNDS ARE MADE AFTER YOUR PERMIT(S) ARE RETURNED. THERE ARE NO REFUNDS ON SEASON PERMITS AFTER AUGUST 15<sup>TH</sup>.

*Check in 2:00pm Friday --- Check out 2:00pm Sunday*

***VEHICLES NOT CHECKED OUT BY 2PM WILL BE CHARGED \$40.00 PER HOUR.***

WE RESPECT YOUR RIGHT OF PRIVACY AND WILL TRY TO MAINTAIN THE HIGHEST SECURITY FOR YOUR SAFETY. IN DOING THIS, WE REQUIRE THAT ALL VEHICLES VISITING YOU BE REQUIRED TO HAVE A VEHICLE PASS. **THERE IS ONLY ROOM FOR 3 VEHICLES PER SITE. CHECK WITH GATE ATTENDANT FOR INFORMATION.** ALL VEHICLES MUST BE PARKED IN FRONT OF THE RV/CAMPER SITE THEY ARE VISITING. DO NOT PARK IN FRONT OF ANOTHER SITE OR IN AN EMPTY SITE. PLEASE MAKE YOUR GUEST(S) AWARE OF THIS RULE.

Overnight Parking Is Restricted To Self Contained Campers/RV'S And Friday/Saturday Nights Only. There Is No Camping In Tents, Cargo Trailers, Cars Or Any Other Type Vessel Not Made As Living Quarters And Not Equipped With Water, Sewer Holding Tanks, Electrical Generated Power Or The Ability To Receive Electrical Power.

## QUIET TIME IS 1:00 AM TO 8:00 AM

- All vehicles are required to have a vehicle pass when entering the campground at ANYTIME. Parking Permits must be prominently displayed at all times and clearly visible from the outside.
- **Camper sites are 18' to 21' wide.** Depending on your camper/RV, you may or may not be able to use both your awning and slides. If using slides in the smaller spaces, you cannot use your awning to its full capacity. ***Do not infringe on your neighbor's site.***
- Open campfires are permitted in containers designed for open fires and a 2#ABC or higher fire extinguisher is required. Cooking outside should be done using approved grills or camp stoves. Be sure to extinguish and dispose of materials used for fires properly.
- The Richland County Sheriff's Department patrols our grounds and is on guard in the RV Lot at all times. Those persons who have become drunk and disorderly or who are consuming alcohol under age are subject to arrest and jail.
- Do not park in areas defined as FIRE LANES or NO PARKING. Your vehicle will be towed at your expense.
- Selling of Goods, soliciting, or the posting of bills is prohibited by the Fairgrounds and by State Law.
- Please assist us in keeping the park clean.
- **PETS:** Dogs, cats, or other similar type animals must be maintained in a cage, on a leash, or in your camper/RV AT ALL TIMES. It is your responsibility to clean up after your pet. Disregarding this policy will force us to revoke your privilege to park on the Fairgrounds. State and County Codes will be enforced.
- **GENERATORS MUST HAVE A STOVEPIPE THAT RUNS UPWARDS AND ABOVE THE ROOF LINE TO REMOVE FUMES PRODUCED. NO EXCEPTIONS!! EXTREMELY LOUD GENERATORS WILL NOT BE ALLOWED.**
- All Golf carts must have \$50,000.00 liability insurance and must be on file with the Fair before you bring or operate your cart. Request for a golf cart permit must be requested the week prior to the game you wish to bring it to. Motorized scooters, mini bikes, go carts, 2 wheeled personal transport platform devices or any other motorized conveyance (with the exception of those being used for the physically impaired) not covered under the Statutes of the Department of Motor Vehicles of South Carolina are not allowed to operate on Fairgrounds property. Operators must be 18 years old and hold a valid drivers license. Golf carts or other motorized conveyance licensed in another state, must follow the same guidelines as if a residence of this state. Operation of such conveyance is solely for the use on property owned, **which is not leased to others**, by the South Carolina State Fair.

**THE STATE AGRICULTURAL AND MECHANICAL SOCIETY OF SOUTH CAROLINA (SOUTH CAROLINA STATE FAIR) RESERVES THE RIGHT TO REVOKE ANY PARKING PERMIT(S) FOR FAILURE TO ABIDE BY THESE RULES AND REGULATIONS. IF A PERMIT IS REVOKED, NO REFUNDS WILL BE ISSUED AND YOU MUST VACATE THE PROPERTY IMMEDIATELY. WE TAKE ALL PRECAUTIONS TO INSURE A SAFE AND SECURE ENVIRONMENT WHILE YOU ARE HERE, BUT THE SOUTH CAROLINA STATE FAIR WILL NOT BE HELD LIABLE FOR ANY LOSS, THEFT OR DAMAGES TO ANY PERSONAL OR REAL PROPERTY OR INJURIES SUSTAINED DUE TO YOUR NEGLIGENCE. THIS PROPERTY IS UNDER THE JURISDICTION OF THE RICHLAND COUNTY SHERIFF'S DEPARTMENT.**
